The James River Soil Conservation District Scholarship Program encourages young people to pursue careers in conservation.

This scholarship is intended for a student going into an **Agricultural, Natural Resource Management, Environmental or related fields** at a two or four year university in the state of North Dakota.

- Applicant must be a resident of Dickey County, ND.
- \$500.00 scholarship will be awarded to chosen applicant. Applicants will need to maintain at least a 2.5 GPA and be a full-time student. Scholarship will be paid after the James River SCD receives the Fall 2025 semester transcript. The \$500.00 will be sent to the school of attendance. If the scholarship winner does not maintain the 2.5 GPA, a second place qualifier will be awarded the \$500.00. This scholarship is to be paid on a one-time basis and is not renewable.
